Background

The Connecting Australian Healthcare – National Healthcare Interoperability Plan 2023-2028 (Interoperability Plan) is Australia's first national plan to deliver a connected healthcare system for more personalised holistic care and better health and wellbeing outcomes for all Australians.

The Interoperability Plan sets out a national vision to share consumer health information in a safe, secure and seamless manner and identifies 44 actions across five priority areas: identity, standards, information sharing (sending, receiving and finding the right information), innovation (initiatives that drive interoperability) and measuring benefits – and policy tools to support interoperability.

The Australian Digital Health Agency (the Agency) has established the <u>Council for</u> <u>Connected Care</u> (the Council) as the key governance body to provide strategic advice, oversee implementation of the Interoperability Plan, and report on progress.

The Interoperability Plan was published on the Agency's website on 11 July 2023. This is the second quarterly progress report against the 44 actions in the Interoperability Plan. The timeframes to initiate the 44 actions are categorised as:

- Immediate within one year (2023-24)
- Ongoing currently underway (2023-24 to 2027-28)
- Short term one to three years (2024-25 to 2026-27)
- Medium term three to five years (2025-26 to 2027-28).



Identity



Identity

Healthcare identifiers support information sharing by accurately identifying individuals, healthcare providers and healthcare provider organisations. This ensures information shared is for the right individual and improves the safety of care provided. It also gives individuals greater control over the level of access they provide to healthcare providers.

This priority area includes 10 actions to leverage the national Healthcare Identifiers Service and the National Health Services Directory:

- 2 actions are immediate (2023-24)
- 4 actions are ongoing (2023-24 to 2027-28)
- 4 actions are short (2024-25 to 2026-27).

Progress highlights

There has been significant engagement with jurisdictions to identify barriers to using healthcare identifiers and discuss the proposed legislative reforms to the Healthcare Identifiers Act 2010. A Healthcare Identifiers Roadmap to increase the adoption and use of healthcare identifiers is nearing finalisation ahead of intergovernmental sign-off in 2024.

Stage 2 of the national rollout of Provider Connect Australia (PCA) that commenced in July 2023 has seen 1,969 healthcare organisations register for PCA, along with 34 of their business partners.

Key interoperability and data flows between healthcare service directories is being discussed in the context of a national health information exchange. Data quality activities and system improvements to the National Health Services Directory continue with all work plan activities expected to be delivered by 30 June 2024.

Standards



Standards

To seamlessly exchange or access health information and ensure consistent understanding, it is essential to have agreed digital health standards, specifications and terminology.

This priority area includes 14 actions to drive effective leadership and a sustainable approach to standards governance:

- 5 actions are immediate (2023-24)
- 4 actions are ongoing (2023-24 to 2027-28)
- 5 actions are short (2024-25 to 2026-27).

Progress highlights

The Australian Digital Health Standards Advisory Group met for the second time on 14 December 2023 and discussed the National Digital Health Standards Catalogue, feedback on the draft gap analysis prepared for the Aged Care Clinical Information Systems Standard, and uplift projects for the National Clinical Terminology Service.

The Sparked FHIR Accelerator program, a cooperative between the Agency, CSIRO, HL7 Australia and the Department of Health and Aged Care, is advancing. The Clinical Design Group met virtually on 9 November and 5 December 2023 to provide feedback on a proposed core dataset for interoperability (Release 1). The Technical Design Group has met virtually twice per month and continues to progress development of the AUCore Implementation Guide.

Information sharing



Information sharing

The sharing of information between healthcare providers and consumers requires information to be discoverable and accessible within a framework of trust, safety, consent, privacy and data quality.

This priority area includes 12 actions to increase the safe, secure and seamless sharing of information with the right people at the right time:

- 3 actions are immediate (2023-24)
- 2 actions are ongoing (2023-24 to 2027-28)
- 4 actions are short (2024-25 to 2026-27)
- 3 actions are medium (2025-26 to 2027-28).

Progress highlights

Progress has been made towards a national health information exchange (HIE) roadmap and architecture that will enable real-time data sharing between primary, acute and aged care settings supported by all jurisdictions under the Intergovernmental Agreement on National Digital Health 2023-2027. The Agency has completed consultations with each jurisdiction to discuss and confirm the scope and phasing of the HIE, with a number of jurisdictions identified as being possible early adopters of HIE Phase 1.

The Department of Health and Aged Care is engaging with jurisdictions to understand legislative barriers to health information sharing.

A series of workshops is underway with Tasmania that will provide input to the Phase 1 Service Model and the Agency will soon be exploring other jurisdictional engagements. The Department of Health and Aged Care is commencing engagement with jurisdictions to understand legislative barriers to health information sharing.

The Agency has extended its contract for FHIR Fundamentals for Australian Developers training with HL7 Australia as there has been significant demand for this training. The Agency has also commenced a gap analysis of interoperability education materials that will inform the development of materials in the future to fill any gaps.

A HL7 AU FHIR/Sparked Connectation was held in Melbourne on 20-21 November 2023 to continue to advance the implementation of FHIR in Australia and facilitate open interoperability.

- 1 action is short (2024-25 to 2026-27).

Progress highlights

The Council for Connected Care, that governs the Interoperability Plan, met for the third time on 11 October 2023 and covered the standards priority area. The next meeting is scheduled for 22 February 2024 and will cover the information sharing priority area.

Planning has commenced for the second national interoperability survey in 2024-25 and work continues to assess different maturity frameworks. The Agency has recently introduced a sub-set of interoperability survey questions in its quarterly healthcare provider survey that will help track changes over time.
