



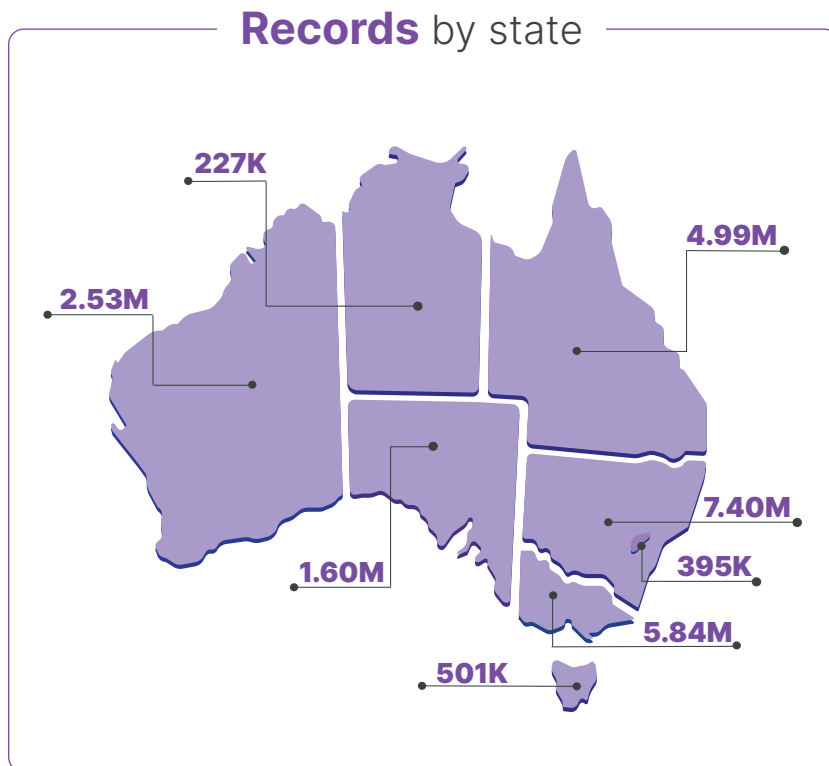

# Statistics and Insights

DECEMBER 2022

The Australian Digital Health Agency publishes a range of statistics about how My Health Record is being used by healthcare provider organisations and patients.

The statistics include information about registrations, document uploads and prescription/dispense documents.



Almost **23M records** have data in them

That's almost **98%** of all records



The volume of records with data in them has grown by almost **700K** in the last year.

There are over  
**830M**

documents in the system that  
have been uploaded by  
**consumers** or **healthcare  
providers**.

uploaded by a healthcare provider like hospitals,  
pathologists and increasingly specialists.

**MEDICINE DOCUMENTS**

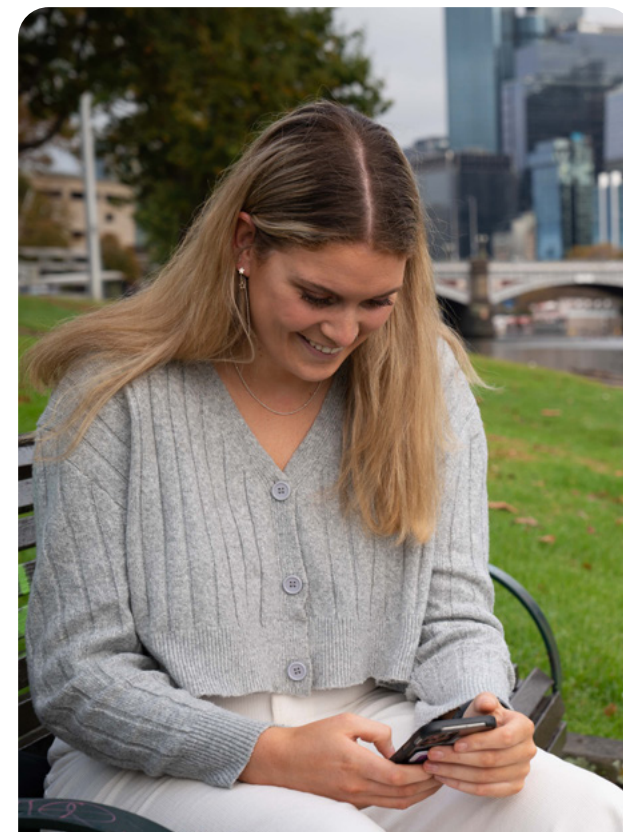
**486M**

**464K**

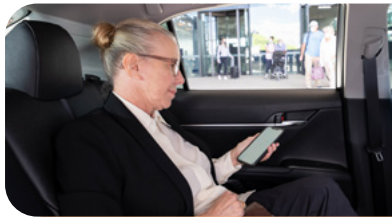
uploaded by people.



**265K** people have registered  
for a My Health Record who had  
previously opted out or cancelled.

Australians trust My Health Record to keep their health information secure and can decide which healthcare providers can view their record.

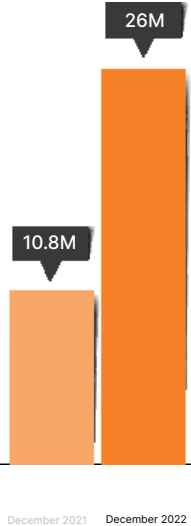
This month over **12K** people checked who had accessed their record.

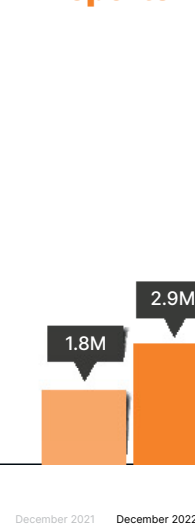

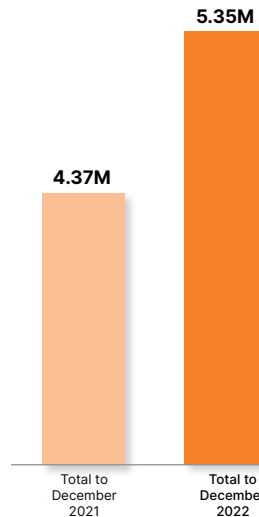

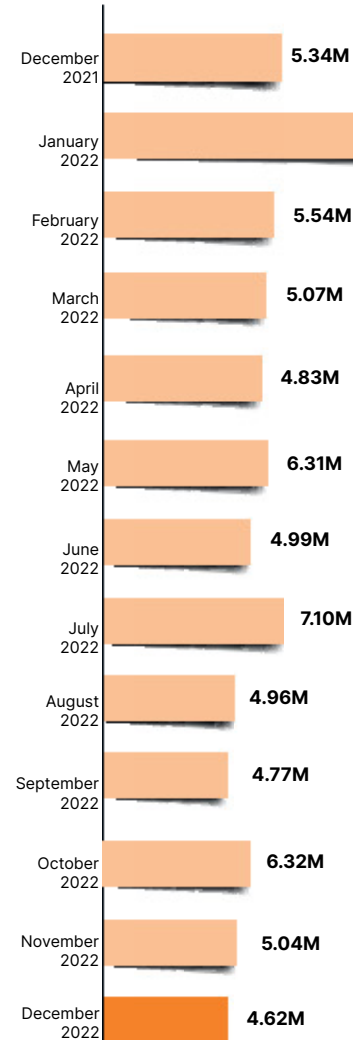

### How many records have been viewed?

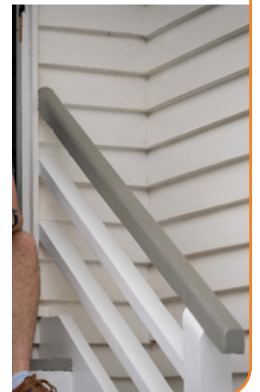
An increase of almost **1 million** in the last year alone

**95%** have used My Health Record

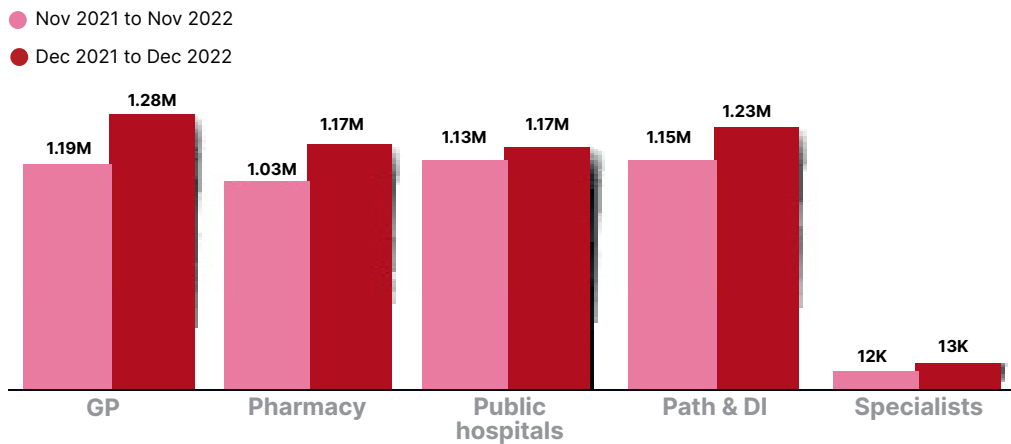

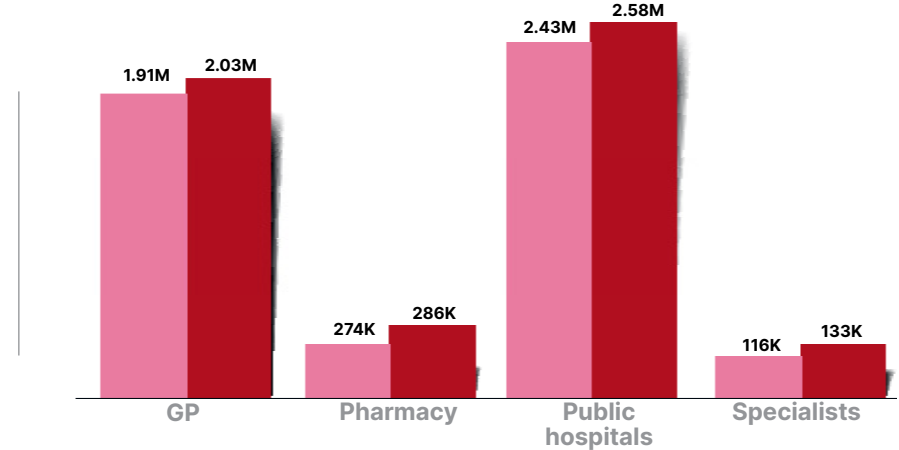
**31%** of specialists are registered

Documents **uploaded** which were **viewed by other** organisations



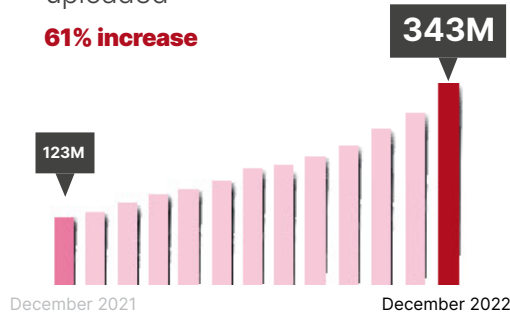
Documents **viewed** which were **uploaded by other** organisations

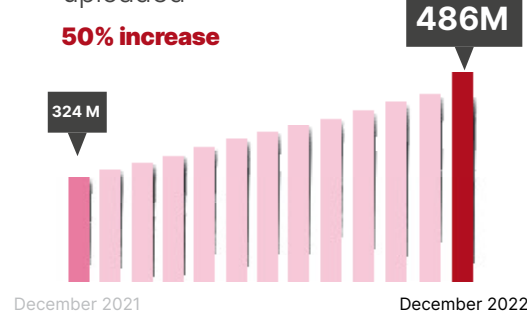
Volume of **clinical documents** uploaded

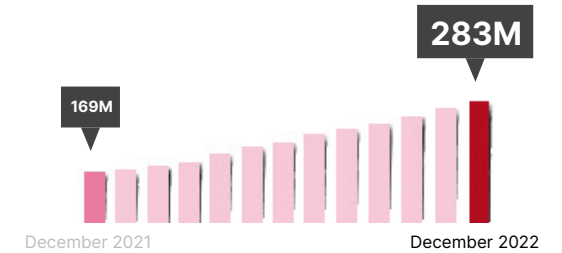
Volume of **medicine documents** uploaded

**50% increase**



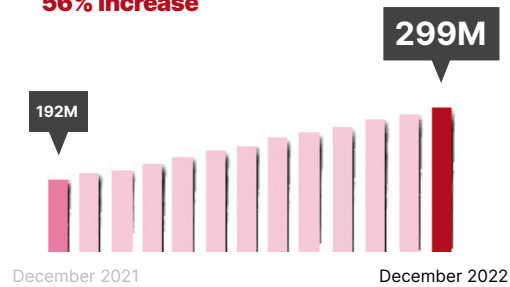
Volume of **pathology reports** uploaded

**68% increase**



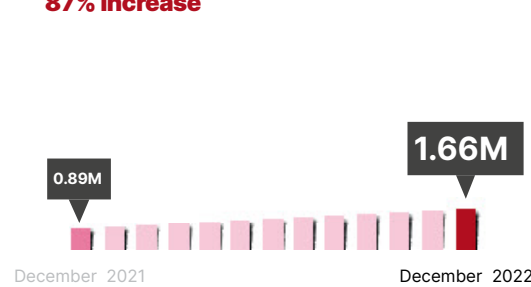
Volume of **dispense records** uploaded

**56% increase**



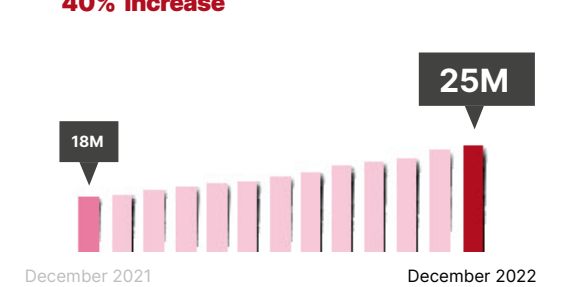
Volume of **specialist letters** uploaded
